In the reference 1st cited, an application was submitted to the Board seeking Consent for Establishment (CFE) for set up a Common Bio Medical Waste Treatment and disposal Facility (CBMWTF) at Plot No. 36/B, Biotech Park, Phase - III, Karakapatla Village, Mulugu Mandal, Medak District with installed capacities of incinerator-200 kg/hr. The total cost of the project is Rs. 1.63 crores and will be situated in an area of 2 Acres (8,094 Sq.m.)
- ii. The above site was inspected by the AEE, R.O-II, RC Puram, T.S. Pollution Control Board on 12.02.2015 and it was observed that the proposed site is surrounded by
East: Plot No. 36/A
West: Plot No. 36/C
North: Private Land
South: Existing 30.00 M wide road
- iii. The Board, after careful scrutiny of the application and verification report of Regional Officer, hereby issues CONSENT FOR ESTABLISHMENT to your facility Under Section 25 of Water (Prevention & Control of Pollution) Act 1974 and under Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and the rules made there under. This order is issued for establishment of the Common Bio-Medical Waste Treatment Facility mentioned at para (1) only.
- iv. This Consent Order now issued is subject to the conditions mentioned in Schedule 'A', Schedule 'B' and Schedule 'C'.
- v. This order is issued from pollution control point of view only. Zoning and other regulations are not considered.


